## **Annual Meeting Highlights**

A group of 17 attended the Association's annual meeting and potluck dinner on June 14 in White Pines Park. Highlights of the meeting included a recap of the paving done in May (see below), and discussion of the need to clarify and/or amend the covenants and bylaws, particularly concerning rights-of-way and easements.

Mack Tobias was elected to the board, replacing outgoing Director and Secretary Beth Stoneburner. At the next board meeting in June, Gordy Roberts was elected President, Mack Tobias was elected Vice President, Penny Mann was elected Treasurer, and Beth Stoneburner agreed to remain as a non-director officer continuing to serve as Secretary. By far the biggest expense the Association had this past year was the paving done in May – approximately 1500 linear feet for the almost \$38,000 paid. The increased assessments that we are now collecting mean that a larger portion of the budget each year can be set aside for additional paving, which will be the constant and major expense the Association will have in the future.
